Rules: The regatta will be governed by the 'rules' as defined in the Racing rules of sailing, as modified by Appendix E.

Eligibility: The regatta is open to all boats recorded with the EC-12 Class.

Times: Skippers meetings 9:30 AM Saturday, 9:00 AM Sunday
Saturday races begin at 10:00 AM, No races will start after 3:30 PM.
Sunday races begin at 9:30 AM, No races will start after 12:30 PM.

Location: Ashland Pond, The Villages, Florida (detailed directions with frequency assignment)

Entry: Eligible boats may be entered by completing the attached Registration form and submitting it prior to September 30, 2009 with an entry fee of \$30.00, guests \$5. Entry fee includes coffee, soft drinks and early snacks both days plus lunch on Saturday.

Scoring: The Low Point Scoring System of Appendix A will apply, using the Florida EC-12 Association TWO-FLEET System. If at least 8 races are sailed, a boats worst score will be excluded. For every increment of 8 additional races sailed, one additional worst score will be excluded from her overall score.

Prizes: At least three and no more than five prizes per fleet will be awarded depending on the number or boats entered.

Release Waiver of Liability and Indemnity Agreement for Sumter Landing and Village Center Community Development Districts and Sumter Landing EC12 Model Yacht Club

In consideration of being permitted to participate in recreational activities or events sponsored, promoted, held, or conducted by Releasee (The 'Activities'), I, for myself, and for my executors, administrators, persons, representatives, assigns, heirs, and next of kin, DO HEREBY:

1. RELEASE, WAIVE, FOREVER DISCHARGE, HOLD HARMLESS, AND COVENANT NOT TO SUE The Villages of Lake-Sumter, Inc., The Village Center Community Development District, Sumter Landing Community Development District, State of Florida Sports Foundation and Sumter Landing EC12 Model Yacht Club, any sponsor, advertiser, and promoter of any of the Activities, and any owner or lessee of the premises used to conduct or hold the Activities and each of them, their officers, directors, members, executives, agents, employees, affiliates, department representatives, successors and assigns (collectively and individually the 'Release') of all liability to me or my executors, administrators, personal representatives, assigns, heirs, and next of kin, for any and all loss or damage, and all claims or demands therefore, on account of injury to my person or property or resulting in my death, arising out or in any way connected with my participation or involvement in or presence in the Activities, suffered before, during or after the Activities, whether caused by the negligence, action or inaction of Releasee or otherwise.
2. INDEMNIFY AND HOLD HARMLESS Release from and against any loss, liability, damage or cost that I or any of my guests may incur due to participation, involvement or presence at the Activities, whether caused by negligence, action or inaction of Releasee or otherwise;
3. ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or in any way connected with my participation or involvement in or presence at Activities suffered by me before, during or after the Activities, whether caused by the negligence, action or inaction of Releasee or otherwise. I understand that my participation or involvement in or presence at the Activities carry the risk of injury or death or property damage and I accept that risk freely and voluntarily;
4. AGREE that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by Florida law, and that if any portion is held invalid for any reason, the balance should notwithstanding, continue in full legal force and effect;
5. AGREE that the foregoing agreement is intended to apply to any participation or involvement in or presence at any Activity or event by me and my guests, which are sponsored, promoted held or conducted by Releasee until such time I deliver written revocation of this agreement to The Village Center Community Development District or Sumter Landing Community Development District. No representations or inducements apart from the foregoing have been made by the Releasee.
